This is a partial response to your request under the Freedom of Information Act (FOIA) for access to records maintained by the Office of the Inspector General (OIG). Specifically, you seek the "Title Pages, Tables of Contents, and Executive Summaries of each final, non-public Inspector General report created since January 1, 2005, that falls under [specified] report categories listed on the Office of the Inspector General's website." The OIG located documents responsive to your request. It has been determined that these documents are appropriate for release without excision and a copy is enclosed.

Because the non-published reports had not been requested previously under the FOIA, we are conducting a review of the reports for disclosure determination and we anticipate that we will be able to make the reports available, in full or in part, on our website at www.usdoj.gov/oig/reports under the heading "External Reports."

We will continue to review the responsive records and process your request as expeditiously as possible.

If you are not satisfied with my response to this request, you may administratively appeal by writing to the Director, Office of Information Policy (OIP), United States Department of Justice, Suite 11050, 1425 New York Avenue, NW, Washington, DC 20530-0001, or you may submit an appeal through OIP's FOIAonline portal by creating an account on the following web site: https://foiaonline.regulations.gov/foia/action/public/home. Your appeal must be postmarked or electronically transmitted within 60 days of the date of my response to your request. If you submit your appeal by mail, both the letter and the envelope should be clearly marked "Freedom of Information Act Appeal."

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. See 5 U.S.C. 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.
