Searches carrier records from cell number in order to find & locate the billing address, customer name and up to 100 calls with dates from previous billing period (or up to last 3 periods). Investigator can only go obtain info less than 90 days old with this search.

### More info:

Your investigator will obtain up to 100 calls from the last billing period. Call reports vary based on carrier and your subjects calling plan. Some include outgoing calls only; others have incoming calls detailed as well. The investigator will not know and cannot find out what is on the report before he obtains it.

Cell phone reports can begin and end on any day of the month. If you are looking for calls made on a specific day, please indicate that in special instructions. The investigator will do his best to obtain that day, but he cannot guarantee it. If you enter a range of days, it may require more than 100 calls and it may span two billing periods in which case there would be additional charges. If for example your subject's cell phone cycle cuts off on the 14th of the month, the investigators report will include 100 calls from the beginning of the last billing period. In this example, calls would start on the 15th of the previous month. If your subject is a light user, your subject may not even have 100 calls or 100 calls could be several weeks of data. If your subject is a heavy user, your report might only include one or a few days of data. The investigator will obtain as many calls as he/she can. If you only want calls from a previous period, please note that in the special instructions. The investigator can only obtain reports less than 90 days old with this search. If your special instructions to the investigator are not clear, or if he has a question determining exactly what you are requesting, he can contact you via the online messaging system.

Cell Toll Reports are obtained by private investigators for your personal informational purpose only. These reports are NOT valid in a court of law. Clients ordering these reports are hiring a private investigator on there behalf to ferret out information garnished from these reports in order to perform due diligence in an ongoing investigation.
