## Dear Secretary Nielsen:

We write to you regarding the personal voter data obtained by the Presidential Advisory Commission on Election Integrity. We represent the organizations that sued the Commission for various violations of federal law.

By Executive Order issued on January 3, 2018, the President revoked the authorities established by Executive Order 13799 and accordingly terminated the Presidential Advisory Commission on Election Integrity.

However, shortly after the issuance of the Executive Order, former Commission Vice Chair Kris Kobach told several news organizations that he intended to pursue the work of the Commission at the Department of Homeland Security ("DHS"). Mr. Kobach also indicated that the personal data obtained by the Commission would be transferred to the DHS.<sup>2</sup>

We write to emphasize that neither Mr. Kobach nor the defunct Commission have authority to transfer the data obtained by it to any third party, including the DHS. The disposition of all materials obtained or created by the Commission is subject to multiple federal laws, including the Federal Advisory Committee Act, 5 U.S.C. app. 2, the Federal Records Act, 44 U.S.C. chs. 21, 29–33, and the Presidential Records Act, 44 U.S.C. §§ 2201–2207, under the direction of the Administrator of General Services. 41 C.F.R. pt. 102-3, subpt. D, app. A.

Moreover, accepting or maintaining personal voter file data from Mr. Kobach or the Commission would subject the DHS to obligations under the E-Government Act of 2002, 44 U.S.C. § 3501 note, the Privacy Act of 1974, 5 U.S.C. § 552a, and the Paperwork Reduction Act, 44 U.S.C. §§ 3507–3521.
