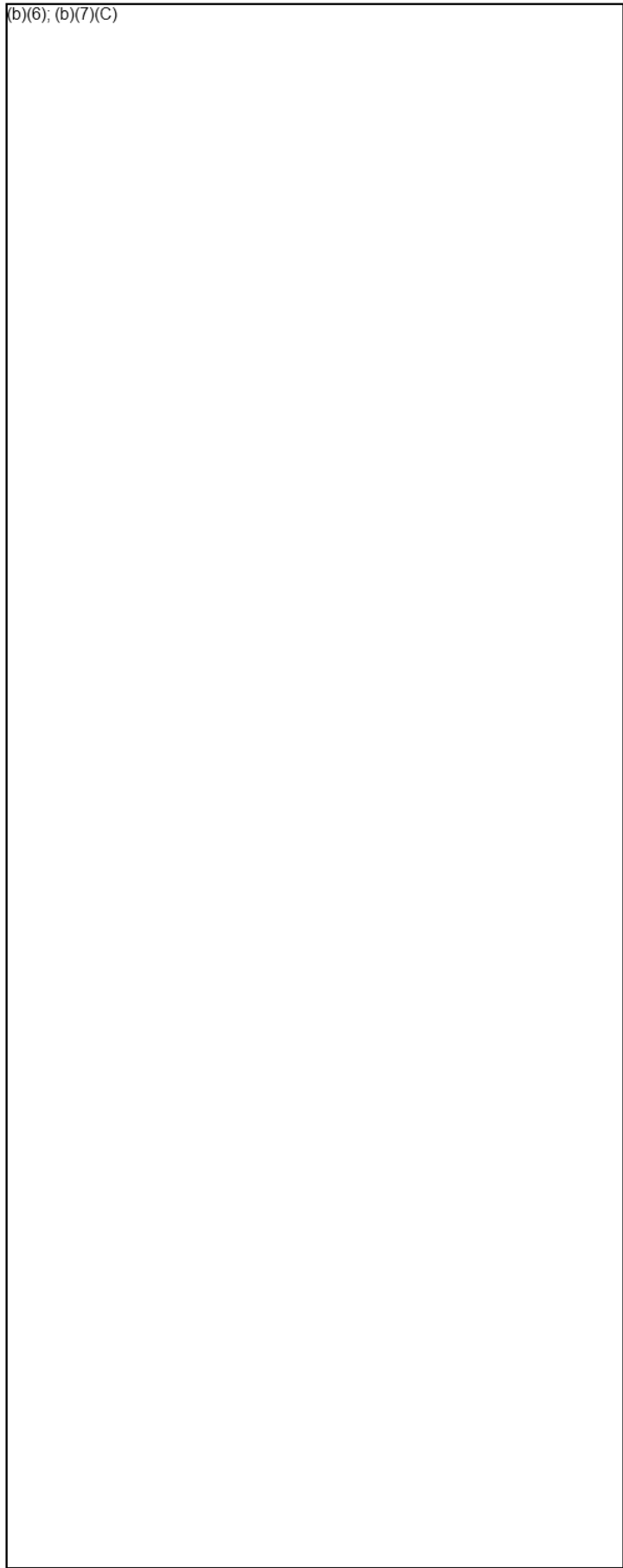

I typed this up for my own use during the meeting, thought I'd share in case it's useful.

**(b)(6),(b)(7)(C),(b)(5)**

**(b)(6),(b)(7)(C)** Clearview first came across IGP's desk in 2019 when HSI submitted a PTA for the use of this technology. As Clearview became more noticeable in public view, IGP put out a data call on offices outside of CEIU to determine who was using it, and IGP found that over **(b)(7)(E)** offices around the country were using Clearview, because the license is so cheap. IGP created a pilot program for the use of Clearview where only CEIU would use it while IGP was creating a more fleshed out infrastructure and drafting a privacy impact assessment and training requirements.

**(b)(6),(b)(7)(C)** (Requests a copy of the training)

**(b)(6),(b)(7)(C)**: We can send a copy of the PowerPoint but there's also a PALMS training. As CEIU was testing out the efficacy of Clearview, IGP built out facial recognition administrative safeguards. IGP has done what they need to do, so they are deferring to leadership to determine how to go forward.

**(b)(6),(b)(7)(C)**: Weren't we discussing whether there would be another PIA that is agency-wide?

**(b)(6),(b)(7)(C), (b)(5)**

**(b)(6),(b)(7)(C), (b)(5)**

**(b)(6),(b)(7)(C)** Are you using it for identity fraud investigations/how is it used.

**(b)(6),(b)(7)(C)**: Yes. To make a search, you upload an image of a face and Clearview will match it to an open source, usually social media photo. A best practice would be to use multiple photos from multiple sources.

**(b)(6),(b)(7)(C)** How many people would have access?

**(b)(6),(b)(7)(C)** The last time we had access it was **(b)(7)(E)** censuses. CEIU has **(b)(7)(E)** censuses, and they give them to field personnel. He assumes that each field person has to take the 3-hour training, but he's unsure what other instructions they receive. He's unsure how it's used in the field.

**(b)(6),(b)(7)(C)** Do you know where the oversight would live if it was not CE?

**(b)(6),(b)(7)(C)** HSI-wide, he is unsure.

**(b)(6),(b)(7)(C)** OSDM would be the oversight office for facial recognition programs.

**(b)(6),(b)(7)(C)** Why aren't they now?

**(b)(6),(b)(7)(C)** OSDM is a new program so we're still getting it off the ground. CEIU started it with Clearview but it will switch over as OSDM develops further.

[REDACTED] Who else from Lead Development Center are we talking about?

(b)(6),(b)(7)(C) Field Office SACs are requesting it, currently they are not allowed under the PTA, but if they are granted licenses they could use it for every kind of investigation.

[REDACTED] Just as a reminder, any new expansions or renewals of Clearview are barred by the AD1 memo.

(b)(6),(b)(7)(C) Correct.

[REDACTED] (b)(5)

(b)(5)

(b)(6),(b)(7)(C) We're still trying to piece that together.

[REDACTED] Right now, as drafted, the Directive requires a case summary forwarded to IGP and ORAP for review before the license can be granted. It will have to be a pretty big justification for each line of investigation.

[REDACTED]: We need rules of the road that we currently don't have, and there's going to have to be a very good reason for expansion.
