- It is a series of assertions that can help us refine our focus and incorporate your ideas. It is intended to assess the current state of play, not provide recommendations (though some points lean in that direction).
- It contains claims and judgments only, and does not currently have supporting explanation, analysis, or evidence. With your feedback, we
 can develop this further into a more refined framework for the November report.

We would greatly appreciate your substantive feedback and comments on the <u>draft document attached here</u>. Please review <u>by Sept 1</u>, and feel free to write directly on the document or send us your comments by email.

At the same time, Working Groups are preparing research memos for you to review and discuss at the September WG meetings. These are important for generating more "meat" for the report, and we ask you to engage closely with your WG staff leads on the memos this month and next.

2-Reaction to the Initial Report

Thanks to Tara and (b) (6) we had a great success submitting our first report to Congress and conducting some media attention.

We released our Initial Report to Congress and more widely at 9am on July 31, and posted it on our new website (www.nscai.gov).

Reporting was straightforward, and drew accurately from the press release and report language, as well as from a limited media engagement led by Vice Chair Bob Work on July 31.

Hill: We have received positive initial feedback from the House and Senate Armed Services Committees, and from the Senate Select Committee on Intelligence. Committee staff members also expressed an eagerness for our recommendations.


