This sounds very good.

I am wondering if you might have the time to check in with CRA, AAAI and/or NAS on stats around career paths of folks in the areas of CS, statistics and (if available) AI.

The kinds of numbers that would be useful would be time series over the past N years on counts of number of people starting in the following career stages: starting an undergrad degree, starting a PhD, starting a faculty career, starting a faculty career in a top university (maybe use AAS as a proxy). Broken up ideally by gender and whether the person is domestic versus international.

Dr. Moore,

I hope this finds you well! Following identification of a date and time for the working group's first meeting on May 8th, we've built out a draft agenda along the lines of the approach we discussed in our initial brainstorming call, albeit scaled down to fit within the two hour time slot we have to work with.

I've attached it here for your feedback. We are ready and available to connect for a quick phone call in the coming days to discuss in greater detail, should you be interested to do so.

You'll see that we've set up the afternoon to open with a brief scene setter capturing the broad trends in US/China/Europe AI research landscapes from the authors of the AI Index (specific briefer TBD). We've asked them to also draw out the implications of these trends for US policy and highlight where there are deficiencies in data that, if addressed, could improve decision-making and prioritization. This snapshot will be followed by a presentation on the US academic community's proposed response to this landscape: the 20-year AI Research Roadmap for the U.S. developed by CRA Computing Community Consortium and AAAI. We would then close this portion of the agenda with a discussion with both briefers.

The second section of the agenda will focus specifically on DoD investment in AI research and development, featuring analysis from a private-sector firm, Govini, who has done some compelling data analysis around how much, in which issue areas and with who the DoD has focused its investments in AI.

Finally, we'll close with executive time for you and the other commissioners to discuss the issues you would like to bring to the plenary session on May 20, the hard questions identified from the briefings to take forward for further assessment, and a framework around which to organize the working group's efforts going forward. Along these lines, I've also attached for your consideration an initial draft of a possible framework.

Once you are comfortable with the agenda for the 8th, I'll share with Dr. Schmidt and Dr. Horvitz for their feedback and awareness.

Again, we stand ready to hop on a call to talk through any of the above at your convenience. Thank you in advance for your feedback.

Following up on your inquiry regarding statistics around career paths in computer science, statistics, and AI across undergraduate, PhD and faculty career stages, I attach here analysis pulled together by CRA's Director of Statistics and Evaluation, Betsy Bizot. She used 14 years of data from the CRA Taulbee Survey, covering computer science and AI-specific tracks, highlighting trends in gender breakdown and international students. Unfortunately they do not have similar data on statistics.




